Sports Federation & Olympic Committee of Hong Kong, China 中國香港體育協會暨奧林匹克委員會 General Guidelines of applying for upgrading membership of Associate Member and Association Ordinary Member 申請升格為準會員及正式屬會會員的指南

### I) Associate Member 準會員

- 1. The applicant must usually have held Observer membership status for not less than five years prior to its application for Associate membership status; 申請團體通常必須在申請準會員資格之前至少擁有五年觀察會員身份;
- 2. The applicant's sport must either be a sport in the past Olympics or a new sport to be included in the next coming Olympics; 申請團體的所屬運動項目必須曾是奧林匹克運動會項目或是下一屆奧林匹克運動會的新增項目;
- 3. The recognition of the applicant's sport on the Olympic Games (Summer/Winter) or the Asian Games (Summer/Winter); 申請團體的所屬運動項目是奧林匹克運動會(夏季/冬季)或亞洲運動會(夏季/冬季)認可的運動項目;
- 4. The applicant must be affiliated to International Federation / Asian Federation of its sport;

申請團體必須隸屬相關運動項目的國際/亞洲體育總會;

- 5. The applicant must have demonstrated its ability by organizing coaching seminars and judging courses in the past three years; 申請團體必須在過去三年期間曾舉辦教練研討會和裁判課程;
- 6. The applicant must organize no less than one international or inter-regional championship and one local championship each calendar year in no less than three years in the past five years; 申請團體必須於過去五年的三年期間,每年至少舉辦一個國際或地區錦標賽以及一個本地錦標賽;
- 7. The applicant should have a record of participating in international championship/ regional games/ multi-sports games and its members must have achieved good results as a result of their participation; 申請團體應曾參加國際/地區錦標賽/綜合項目運動會比賽,並取得良好成績;

- 8. The competition results of the applicant organizations as reflected in the Incentive Awards Scheme of the Federation in the past three years; 申請團體過去三年期間均獲得本會獎勵計劃以反映其比賽成績;
- 9. The attendance of concerned applicant organization representatives to Council Meetings and the official events, and functions of the Federation in the past three years;

申請團體的代表在過去三年期間曾參與本會的會議和正式及有關活動。

- 10. The participation level of the applicant organization concerned in the annual mega events of the Federation, i.e., Hong Kong Sports Stars Awards, Festival of Sport, Olympic Day, etc in the past three years; and 申請團體在過去三年期間參與本會年度的大型活動,例如香港傑出運動員 選舉、體育節、奧運日等的參與率;及
- 11. The timely payment of the annual subscription fee by the applicant organization concerned in the past three years.
  申請團體在過去三年期間準時繳交年度會費。

#### II) Association Ordinary Member 正式屬會會員

- 1. The applicant must usually have held Associate membership status for not less than ten years prior to its application for Association Ordinary membership status:
  - 申請團體通常必須在申請正式屬會會員資格之前至少擁有十年準會員身份;
- 2. The applicant's sport must either be a sport in the past Olympics or a new sport to be included in the next coming Olympics;
  - 申請團體的所屬運動項目必須曾是奧林匹克運動會項目或是下一屆奧林匹克運動會的新增項目;
- 3. The recognition of the applicant's sport on the Olympic Games (Summer/Winter) or the Asian Games (Summer/Winter);
  - 申請團體的所屬運動項目是奧林匹克運動會(夏季/冬季)或亞洲運動會(夏季/冬季)認可的運動項目;
- 4. The Applicant must be affiliated to International Federation / Asian Federation of its sport;
  - 申請團體必須隸屬相關運動項目的國際/亞洲體育總會;
