

Election of SF&OC Athletes Committee Members – Voter Registration Form
港協暨奧委會運動員委員會選舉 - 投票人登記表

Who may register?

- (1) Athletes must first register as voters before they can vote.
- (2) Athletes who have participated in at least one of the last three editions of the Olympic Games (i.e. 2016, 2020 and 2024 Summer Olympics and 2018, 2022 and 2026 Winter Olympics) or Asian Games (i.e. 2018, 2022 and 2026 Asian Summer Games and 2011, 2017 and 2025 Asian Winter Games) are eligible to register as voters, but they may only register in their respective categories [i.e. Olympic Games sports or Asian Games sports (excluding Olympic Games sports)].
- (3) If an athlete belongs to both categories, he must choose to register in one category only.
- (4) Athletes who are currently under sanction for a doping offence shall not be eligible to vote.
- (5) No voting by proxy is allowed.

投票人資格

- (1) 運動員必須先登記成為投票人方可投票。
- (2) 曾於過去三屆奧運會 (即 2016、2020 及 2024 年夏季奧林匹克運動會，以及 2018、2022 及 2026 年冬季奧林匹克運動會) / 亞運會 (即 2018、2022 及 2026 年亞洲夏季運動會，以及 2011、2017 及 2025 年亞洲冬季運動會) 中參與至少一屆的運動員即符合資格登記為投票人，惟運動員只能在所屬組別登記為投票人，即「奧林匹克運動會組別」或「亞洲運動會組別」(不包括奧林匹克運動會項目)。
- (3) 運動員如果同時符合兩個組別的登記資格，只可選擇在其中一個組別登記為投票人。
- (4) 因違反運動禁藥管制規條而正被處分的運動員不可投票。
- (5) 投票人不可委任代表投票。

Personal Information Collection Statement

Purpose of Collection

The information provided in this Form will be used by SF&OC for voter registration and election-related purposes. Please note that if you do not provide adequate and accurate data, we may not be able to process your application for registration as a voter. If SF&OC has confirmed that you are eligible to be registered as a voter, your name will be compiled in a register, which may be provided to candidates for the purpose of electioneering.

Transfer of Information

Where necessary, the information provided by you may also be provided to other authorized organisations / persons for the purposes of voter registration and election.

Access to Personal Data and Enquiry

In accordance with the Personal Data (Privacy) Ordinance, you have the right to access and amend your personal data held by SF&OC.
